Grant funding for Maker Master. N. Chan noted that there may also be some additional local resources that may be available to help with STEM type activities, such as the Professional Engineers of Ontario or the Canadian Nuclear Society.

Old Business:

N. Chan provided a brief update on the CEO evaluation committee and that a recommendation is expected for the May meeting.

New Business:
